Graduation Rates

Mr. Eisenhauer provided information regarding graduation rates. The 2019-2020 Campbell County School District four-year graduation rate was 84.31% which exceeded the State rate of 82.3%. This is the District's highest graduation rate in nine years. Five years ago the District graduation rate was at 74% which was below the state rate. Five and six year graduation rates were also shared.

Facility Update

Mr. Holmes provided an update on the Kid Clinic which is on schedule for completion in April. The Campbell County Health Care Foundation, Festival of Trees, donated \$50,000 to the Kid Clinic for furnishings. In addition Campco Federal Credit Union has made a pledge to donate \$12,000 per year over the next three years to the Kid Clinic.

Trustee Celebrations

Chairman Ochs celebrated the graduation rates as well as expressing gratitude to all

the staff who make it possible for our students to be in school full-time.
