funding to update the books in the library.

1) Describe your project's purpose:

#### **Library Enhancement:**

Recluse Elementary is looking to enhance the library books available to students. With the generous donation during the 2019-2020 school year, we were able to update many titles in our library. For this year's grant application, we are looking to enhance the library choices for students. The Library Enhancement proposal is vital to keeping high interest books within reach of our students.

#### **Agricultural Exploration:**

The agricultural exploration will challenge students to plan, design, and engineer hydroponic systems to grow fruits and vegetables year-round. Another purpose of this project is to build a community garden/greenhouse that can be utilized by students and families during the spring, summer, and fall months.

2) When will you implement your project?

These projects will be implemented at the start of the 2021-2022 school year.

3) What age group or grade will your project involve?

These projects will have an educational impact on students Kindergarten through Eighth grade.

5) Specify what opportunities will be provided to the school children through your project?

The goal of the library enhancement will allow the students of Recluse School to have access to literacy. The more they read the better their vocabulary, reading and writing skills become.

The goal of the agricultural exploration will allow students to develop a deeper understanding of agriculture. Being a rural farming/ranching community, students already have the basic understanding of agriculture. This project will allow students to gain first-hand knowledge through hands on activities, but also challenge them to apply the content knowledge they are learning in the classroom to real life situations. All students, Kindergarten through Eighth grade, will be applying lessons they learn in science, math, stem, and language arts to create a sustainable food source.

6) Why should this project be funded?

The library enhancement in our school should be funded in order to provide our students with the opportunity to read new and updated books. Our students are located 35 miles North of Gillette and have very limited access to literacy resources such as the Campbell County Public Library. Being a rural school, it is challenging to keep an updated book selection because we can't generate the same revenues as in town schools can with their book fairs. A library that contains exciting new books will have a tremendous impact on the literacy on the students that attend our school.

Agriculture is a key component in a rural community. The agricultural exploration project will allow students to deepen their knowledge they have of agriculture and create systems that are an extension of their knowledge. They will be given authentic learning opportunities throughout this project that will require them to apply the knowledge and content they've learned throughout their lives. This project will impact

students' understanding of the content they have learned by giving them hands on activities where they can conceptualize their knowledge with experiences.

7) Describe <u>in detail</u> what activities will be involved in your project and how those activities relate to the purpose of your project in assisting the education of Campbell County girls and boys. Attach additional pages as necessary.

The library project will enhance the books that are located in the Recluse school library. By increasing the library all students will be impacted by the knowledge they are exposed to and their literacy skills will improve as well.

Students will be building hydroponic devices to grow a sustainable food source year-round. This relates to assisting their education through multiple content areas.

STEM (Science/Technology/Engineering/Mathematics)
Science, all students learn about plants and the life cycle and eventually
the students will be using chemistry to test the PH levels and nutrients in
the water used to feed their crops.

Technology, students will be using water pumps and grow lights to successfully develop a hydroponic system.

Engineering, students will be researching, planning, and designing their own hydroponic system.

Math, students will be using their math skills when building their devices and also when they are monitoring their plants as they go through the life cycle.

The greenhouse will challenge students to design a layout that will maximize the greenhouse's space. Students will be able to take a seed and grow a plant while studying a plant's life cycle. Those plants will be monitored during the school year and families will have the opportunity to help maintain the plants throughout the year in the community garden. By way of the greenhouse and community garden, we will also be able to support community events that bring the community together to celebrate and support the students. We hold a yearly Halloween

Carnival and will use the pumpkins to enhance the carnival. Fruits and vegetables will be used for the back-to-school barbeque and possibly for a healthy snack for students during the school day.

By using the requested tools students will get some experience of CTE classes that usually aren't offered at rural schools.

8) What are the beginning and ending dates of your project?

The books will be ordered at the beginning of the 2021 school year and be available to all students as soon as possible.

The supplies for the hydroponic devices and tools will be purchased at the beginning of the school year and students will build their devices and use them for the year, and hopefully years to come.

The green house will primarily be used towards the end of the school year in the spring. The community garden will be used in the spring, throughout the summer, and then cleaned and prepared for storage in the fall.

These are the 6 systems that hydroponic devices are built upon.

<u>Wick System</u> – Grow tray, rope wicks, air stone, non-submersible air pump, and air hose.

<u>Water Culture</u> – Water culture uses a floating platform, non-submersible air pump, air stone, and an air hose.

**Ebb and Flow** – Grow tray, overflow tube, submersible air pump, timer, and air hose.

<u>**Drip System**</u> – Grow tray, drip manifold, drip lines, overflow tube, submersible pump, timer, non-submersible air pump, stone, and air hose.

<u>Nutrient Film Technique</u> – Grow tray, overflow tube, submersible pump, non-submersible air pump, air stone, and air hose.

<u>Aeroponics</u> – Aeroponics uses a submersible pump, short-cycle timer, air hose, and mist nozzles.

We budget yearly to try and purchase as many books as possible, but our funding is limited. Being a past grant recipient has allowed us to improve our library selection.

Hydroponic materials and the greenhouse will be able to sustain itself overtime, the upfront cost of materials is what's stopping the project from beginning.

- **4.** Equipment necessary to initiate or enhance a project will be considered. Applications must justify expenditure for equipment.
- 5. All grant applications which could potentially impact structures or grounds of The Campbell County School District, including electrical, plumbing and HVAC, must be reviewed by the CCSD Maintenance Department <u>prior</u> to submitting the application. A copy of a CCSD Maintenance completed work order requesting an impact evaluation of the project must be included with the application. A signed hard copy must be received by Wealth Management, First Interstate Bank, PO Box 3004, Gillette, WY 82717, within two days of submission of this application. Applications will not be considered without this documentation.
- 6. Final reports are required for all completed projects. Copies of receipts are to be attached to the Final Report.
