EDUCATIONAL AGREEMENT BETWEEN SCHOOL DISTRICT AND OUTSIDE AGENCY

This Educational Contract ("Contract") is entered into by Campbell County School District #1, hereinafter referred to as the "CCSD #1," and Achievable Beyond Limited Expectations, hereinafter referred to as the "ABLE," collectively referred to as the "Parties." This Contract outlines the terms and conditions for the provision of educational services by ABLE to the students of the CCSD #1.

### 1. BACKGROUND:

ABLE, as an outside service provider, is in a unique position to offer educational programming to CCSD #1 students in the area of Transition Programming. Through this contract, ABLE will provide programming in the area of Transition as determined by a students' Individualized Education Plan and per collaboration with CCSD #1.

## 2. SERVICES PROVIDED BY ABLE:

ABLE agrees to provide the following Transition programming/services to students at CCSD #1 as per the terms of this Contract:

- Provide programming, including but not limited to, services and opportunities for students with an Individualized Education Plan (IEP) as part of their specially designed instruction and programming as determined and identified as per students' IEP. Programming will specifically address but not be limited to: vocational and pre-vocational skills, functional independent living skills, and recreation and leisure activities.
- -To enhance community learning, ABLE agrees to provide two full days (6 hours, per day), a month, of community-integration and life-skills activities.

# 3. DURATION:

This Contract shall commence on August 21, 2023 and expire on June 30, 2024 unless terminated by either party with written notice or upon completion of the agreed-upon services. Upon agreement by both parties, a contract can be renewed on July 1, 2024.

#### 4. FINANCIAL ARRANGEMENTS:

- CCSD #1 will specify the financial arrangements, including any payments, reimbursements, or grants provided by CCSD #1 to ABLE for the services rendered.
- Cost for the program is dependent on the level of programming/services provided to each student. Programming/services will be billed in fifteen-minute increments (Fifteen (15) minutes equals 1 unit), as established by the Home Community Based Services Waiver Adult Day Services Repayment Schedule. Invoices for services rendered will be submitted by ABLE to CCSD by the last day of each month.

#### 5. RESPONSIBILITIES OF THE SCHOOL DISTRICT:

### CCSD #1 agrees to:

- Comply with all applicable laws and regulations in relation to this Contract.

#### 6. RESPONSIBILITIES OF ABLE:

ABLE agrees to:

- Deliver the educational services as specified in this Contract with the highest level of professionalism and quality.
- Provide a statement certifying the qualifications of the professional staff assigned to each student's case.
- Provide a statement outlining the line of responsibility and supervision of each professional staff member.
  - Maintain accurate records and documentation of services provided.
- Comply with all applicable laws and regulations, including those related to the confidentiality of student information.

### 8. TERMINATION:

This Contract may be terminated by either party with written notice. Termination does not relieve the Parties of any obligations related to services provided up to the date of termination.

### 9. CONFIDENTIALITY:

Both Parties agree to maintain the confidentiality of any student information or other sensitive data shared during the course of this Contract.

10. GOVERNING LAW:
This Contract shall be governed by and interpreted in accordance with the laws of Wyoming.
