SCHOOL IMPROVEMENT GOALS

ELA:

By the end of the 2023-2024 school year, according to the WYTOPP assessment, Lakeview 3rd-6th grade students will meet or exceed the State average in ELA.

Lakeview Elementary will continue our building wide focus on increasing quality Tier 1 core instruction and data-driven interventions. We will promote early-intervention at the primary level using Reading Recovery and Title Interventionists.

MATH:

By the end of the 2023-2024 school year, according to the WYTOPP assessment, Lakeview 3rd-6th grade students will meet or exceed the State average in Math.

Lakeview Elementary will continue our building wide focus on increasing quality Tier 1 core instruction and data-driven interventions. We will promote built-in interventions using our Title Interventionists and para-support.

SCIENCE:

By the end of the 2023-2024 school year, according to the WYTOPP assessment, Lakeview 4th grade students will meet or exceed the State average in Science.

Lakeview Elementary will continue our building wide focus on increasing quality Tier 1 core instruction utilizing Panorama as a resource to increase scientific literacy.

WELL-BEING:

We are continuously building our community and culture to encourage students to become well-rounded citizens.

Lakeview Elementary has established a PBIS Positive Behavior Interventions and Supports) focus throughout the school. PBIS continually seeks to reduce or eliminate negative behaviors school wide by recognizing positive behaviors.

Lakeview Elementary created a Den System and TIGERS characteristics this year to promote community and positive whole-school culture. Students and staff are part of a DEN (Tenacity, Integrity, Grace, Endurance, Responsibility, Strength) where time is spent building relationships and creating positive bonds.

Lakeview Elementary teachers have implemented Character Strong Tier 1 lessons in their classrooms weekly.

Lakeview Elementary has also established a HOPE (Hold On, Persuade, Empower) squad at the lead of our school social worker. This nominated group of students help support other students' health and well being.

Lakeview Elementary continued with Girls on the Run this year.

Lakeview Elementary will continue to work on developing, implementing, and maintaining quality Tier 1 instruction using common instructional units based on priority standards, resources including Heggerty, UFLI, and Panorama.
