

5158-R Campbell County School District Graduation Requirements

The credit requirements for each of the Campbell County School District (CCSD) high schools are as follows:

CAMPBELL COUNTY HIGH SCHOOL CREDIT REQUIREMENTS (9-12)

THUNDER BASIN HIGH SCHOOL CREDIT REQUIREMENTS (9-12)

Course Requirements:

- English - 4 credits (1 **nN**inth **gG**rade English, 1 **sS**ophomore English, 1 **jJ**unior English, and 1 **sS**enior English)
- Mathematics - 3 credits (including Algebra I)**
- Science - 3 credits (including **bB**iology) starting with the class of 2021**
- Social Studies - 3 credits (including 1 **wW**orld **eC**ultures or **wW**orld **hH**istory, 1 U.S./American **hH**istory, .5 U.S. **gG**overnment, and .5 **eE**conomics)
- Physical Education - 1.5 credits
- Health - .5 credits
- Electives - 9 to 12 credits (dependent of the year)

TOTAL CREDITS REQUIRED = 24 2017-18 = 27 credits required (core requirements + 12 elective credits), 2018-19 = 26 credits required (core requirements + 11 elective credits), 2019-20 = 25 credits required (core requirements + 10 elective credits), 2020-21 = 24 credits required (core requirements + 9 elective credits)

Advanced courses may be taken in lieu of required courses listed.

**Students must successfully complete Algebra I and biology.

**Successful course completion prior to grade 9 satisfies the Algebra I requirement but does not count toward the 3 credits required in grades 9-12.

WRIGHT JUNIOR/SENIOR HIGH SCHOOL CREDIT REQUIREMENTS (9-12)

Course Requirements:

- English - 4 credits (1 **nN**inth **gG**rade English, 1 **sS**ophomore English, 1 **jJ**unior English, and 1 **sS**enior English)
- Mathematics - 3 credits (including Algebra I)**
- Science - 3 credits (including **bB**iology) starting with the class of 2021**
- Social Studies - 3 credits (including 1 **wW**orld **eC**ultures or **wW**orld **hH**istory, 1 U.S./American **hH**istory, .5 U.S. **gG**overnment, and .5 **eE**conomics)
- Physical Education/Health – 2 credits
- Electives - 9 to 12 credits (dependent of the year)

TOTAL CREDITS REQUIRED = 24 = 2017-18 = 27 credits required (core requirements + 12 elective credits), 2018-19 = 26 credits required (core requirements + 11 elective

credits), 2019-20 = 25 credits required (core requirements + 10 elective credits), 2020-21 = 24 credits required (core requirements + 9 elective credits)

Advanced courses may be taken in lieu of required courses listed.

**Students must successfully complete Algebra I and biology.

**Successful course completion prior to grade 9 satisfies the Algebra I requirement but does not count toward the 3 credits required in grades 9-12.

WESTWOOD HIGH SCHOOL CREDIT REQUIREMENTS (9-12)

Course Requirements:

- English - 4 credits
- Mathematics - 3 credits (including Algebra I)**
- Science - 3 credits (including biology) starting with the class of 2021)**
- Social Studies - 3 credits (including 1 U.S./American **h**History, .5 U.S. **g**Government, and .5 **e**Economics)
- Physical Education - .5 credit
- Health - .5 credit
- Electives - 10 credits

TOTAL **CREDITS** REQUIRED = 24 credits

Advanced courses may be taken in lieu of required courses listed.

**Students must successfully complete Algebra I and Biology. Starting with the class of 2021, students must successfully complete biology.

**Successful course completion prior to grade 9 satisfies the Algebra I requirement but does not count toward the 3 credits required in grades 9-12.

ADDITIONAL REQUIREMENTS FOR ALL CCSD HIGH SCHOOLS

- Graduation requirements will not be considered completed, nor will a diploma be deemed earned, until payment has been made for all indebtedness due to the school district.
- Student Assistants Any student working as a student teacher assistant will receive one-half (1/2) credit for each semester with a maximum of one credit. This credit will not be included when calculating grade point average or honor roll.
- Transfer students' variations of the credit requirements may be approved by administration after review by the school counselor. Students who transfer to the district during the last semester of their senior year are encouraged to complete requirements necessary for graduation at their previous school. Such students would will then receive their diplomas from the school previously attended.

- A list of advanced courses ~~that allow~~ **allowing** students to earn an advanced performance level in a content area will be maintained by the curriculum and assessment office. The criteria for an advanced determination in an advanced course will be developed/maintained by content area curriculum facilitators working in conjunction with their curriculum committees.

Curriculum facilitators and their respective curriculum committees review assessments for bias to ensure an assessment is appropriate for students with disabilities; acknowledging ~~that~~ students with Individualized Education Program (IEP)s and 504 plans receive appropriate accommodations. Each assessment is also reviewed to ensure it is appropriate for English Language Learners (ELL), identified as Limited English Proficient (LEP) students, acknowledging ~~that~~ students may receive appropriate accommodations. CCSD follows the guidance provided by the Wyoming Department of Education for accommodations for students on IEPs, 504 plans, and English Language Learners. Modifications to assessments are not allowed.
