An ESP employee's supervisor may recommend a certification incentive after the employee meets the established criteria, completes an application process, and is employed for 12 months. Any incentive must be applicable to the employee's position. Employees pursuing certifications must have supervisor approval. Annual fees, testing fees, recertification fees, and continuing education fees will be paid at the discretion of the department supervisor. This discretion will rely heavily on department budgets and department needs. Employees are only allowed one certification incentive within their job title category. Employees seeking a certification incentive should review all requirements for certification (link to requirements is found below in the cross-reference section). Certification incentives are not available for supervisors/managers.

A supervisor making a recommendation for a certification incentive category currently not listed must obtain an incentive application from the Professional Development Office. The application will be reviewed by the Professional Development Committee. Recommendations to add a new incentive will be made by the committee and presented to the Board of Trustees.
