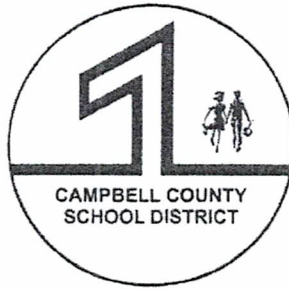

**PREPAID GAS PURCHASE BID**

Campbell County School District wishes to obtain sealed bids for Prepaid Propane Gas for the period of October 2020 to June 30, 2021. Bids due back to the Purchasing Office by 9:00 a.m. on October 5, 2021.

The Contract (if bid is accepted) will be paid in full by October 30, 2021.

There are two sites that will be supplied propane during the contract period: Little Powder Elementary and 4-J Elementary. Bulk of the propane will be delivered to 4-J Elementary.

The gas company's obligation to deliver propane at the prepaid price will remain in force until June 30, 2022, OR until the School District's credit balance is reduced to \$0 OR until the School District has a debit balance on account, whichever occurs first. If the School District has not accepted delivery of the total gallons purchased by June 30, 2022, the School District may apply any credit balance remaining in the School District's account toward the purchase of propane at the current prevailing price, or toward a new Prepaid Gas Purchase Contract.
