### **JOB FUNCTIONS:**

## **ESSENTIAL FUNCTIONS:**

- 1. Evaluates and diagnoses specific speech or language deficits of referred students within the school (s) they are assigned.
- 2. Designs and develops an Individual Education Plan (IEP) for each student that meets the qualifications for direct services for articulation or language deficiency.
- 3. Coordinates the efforts and completes all necessary paperwork and forms to enroll a student in Special Education Programs within the school district.
- 4. Collaborates with all teaching staff in development of a variety of strategies to meet the educational needs of all students within the building.
- 5. Promotes positive public relations with the community and within the school district by using positive verbal and non-verbal communication and interaction skills at all times.

#### **OTHER FUNCTIONS:**

- 1. Follows all school district policies and procedures.
- 2. Assists with the screening activities of students at each building they are assigned to.
- 3. Assists and/or develops new programs as necessary to meet the needs of identification of potential and existing special programs students in the area of articulation or language deficiency.
- 4. Performs other duties as assigned by the building principal.
